25/26 - 0301 Apologies

Ward Councillors gave an update, stating that Council Tax had been set at the recent full Council meeting, with an increase of 2.7%, in addition to the 2% Government add on for Social Care. Ward Councillors confirmed that this increase enabled them to maintain the Community Grant Pot, free swimming in the Easter and Summer holidays for under 16's, free parking, and the Imagination Library.

NLC are looking to provide 200 SEND places in local mainstream schools, along with improving facilities at Baysgarth Leisure Centre.

Councillors reported that the outline Planning Application for the Data Centre at Elsham has been approved.

Councillors raised concerns over the state of the roads in the Low Villages area.
